2021 WISCONSIN STATE FAIR ATTENDANCE SURVEY ONLINE SWEEPSTAKES PROMOTION RULES

ELIGIBILITY: The online sweepstakes promotion is open to legal residents of the United States, who are eighteen (18) years of age or older at the time of entry. Eligible jurisdictions may enter the sweepstakes promotion.
