2024 FRONT ROW FRIDAYS SOCIAL MEDIA CONTEST RULES

ELIGIBILITY: Front Row Fridays ("Contest") are open to legal residents of the United States, who are eighteen (18) years of age or older at the time of entry. Eligible jurisdictions may enter Contest. Contest affiliates, employees, and any entity involved in the production, administration, judging, or fulfillment of the Contest including, without limitation, the immediate family members and/or those persons living in the same household of such individuals, are not eligible to participate. Entries have no value and an entry does not entitle an entrant to any compensation of any type or kind.

This will direct entrants to the Contest entry page. Entrants must complete a short puzzle and then fill out an online entry form, provide full legal name, valid email address, zip code, and date of birth. Must enter contact information to be eligible. All emails will be added to the Wisconsin State Fair Email Database, which has an opt out option.

Week 6 – Casting Crowns with Tauren Wells (6/21-6/23): Eligible entrants must begin to follow, or already be following, Wisconsin State Fair on Instagram, like the post, and tag one Instagram user. Entrant is not contracted to bring the user(s) they tag should they win the Entry Period's prize.

Week 7 – The "Happy Together" Tour (6/28-6/30): Eligible entrants must begin to follow, or already be following, Wisconsin State Fair on Facebook, like the post, and comment what their favorite song is in emojis only.

Week 8 – Riley Green with Avery Anna (7/5-7/7): Eligible entrants must begin to follow, or already be following, Wisconsin State Fair on Instagram, like the post, and tag one Instagram user. Entrant is not contracted to bring the user(s) they tag should they win the Entry Period's prize.

Week 9 – Lauren Daigle with Andrew Ripp (7/12-7/14): Eligible entrants must click on the link provided on the Wisconsin State Fair Facebook Page, Instagram Bio, and Twitter Page. Must enter contact information to be eligible. All emails will be added to the Wisconsin State Fair Email Database, which has an opt-out option.

This will direct entrants to the Contest entry page. Entrants must complete a short quiz and then fill out an online entry form, provide full legal name, valid email address, zip code, and date of birth. Must enter contact information to be eligible. All emails will be added to the Wisconsin State Fair Email Database, which has an opt-out option.

Week 11 – Charlie Berens (7/26-7/28): Eligible entrants must click on the link provided on the Wisconsin State Fair Facebook Page, Instagram Bio, and Twitter Page. This will direct entrants to the Contest entry page. Entrants must fill out an online entry form, provide full legal name, valid email

address, zip code, and date of birth. Must enter contact information to be eligible. All emails will be added to the Wisconsin State Fair Email Database, which has an opt-out option.

Entrants must have a Facebook, Instagram, or Twitter account to participate in the various Entry Periods throughout the Contest. Joining Facebook, Instagram, and/or Twitter are free at <u>www.facebook.com</u>, <u>www.instagram.com</u>, and <u>www.twitter.com</u>. Entrants must be following the Wisconsin State Fair on the social media platform(s) outlined in each entry period to be eligible to win a prize.

For all 11 weeks, winners will also receive a \$25 Festival Foods gift card.
