## 2024 STATE FAIR POSTCARD PROMOTION RULES

**ELIGIBILITY:** The Postcard Promotion is open to legal residents of the United States, who are eighteen (18) years of age or older at the time of entry. Eligible jurisdictions may enter the postcard promotion. Postcard promotion sponsor, affiliates, and employees, and any entity involved in the production, administration, judging, or fulfillment of the postcard promotion including, without limitation, the immediate family members, and/or those persons living in the same household of such individuals, are not eligible to participate.

By entering the postcard promotion, entrants agree to comply with these rules and the decisions of the judges which are final and binding in all respects. Failure to comply with these rules may result in disqualification from the postcard promotion.

All federal, state and local laws and regulations apply; void where prohibited. NO PURCHASE NECESSARY; making a purchase will not improve entrant's odds of winning. Odds of winning depend upon the number of eligible entries received. By entering this postcard promotion, entrants agree to these official rules and regulations.

**SPONSOR and ADMINISTRATOR:** The sponsor ("Sponsor") and administrator of the postcard promotion is Wisconsin State Fair Park ("Administrator"). The entry must be 4 1/8 inches high x 5 7/8 inches long the postcard must depict your favorite Wisconsin crop and the "legend-dairy" Wisconsin State Fair Cream Puff. In the message area, entrants must include three pieces of information: 1) Your favorite Wisconsin crop and Cream Puff; 2) entrants name; and 3) email address (in the event the entrant does not have an email address, a valid mailing address may qualify). Ten winners will be selected via the criteria below to win a prize (see also: PRIZES and SELECTION OF WINNERS).

Entrants will be entered into the postcard promotion upon delivery of the postcard to the Wisconsin State Fair Park. Persons who enter the postcard promotion under false contact information, as

determined by Administrator, will be disqualified and ineligible to win the promotion. Sponsor reserves the right to disqualify any person tampering with the operation or conduct of the postcard promotion. Sponsor reserves the right to cancel, or modify the postcard promotion if it cannot be conducted or completed as planned, for any reason. If the postcard promotion is cancelled, modified, or suspended, notice will be posted on the sponsor website and Facebook page.

All information provided by entrant must be complete, true, and correct. Submissions to the promotion must be postmarked on or before Tuesday, April 30, 2024; entries postmarked after that date will be deemed ineligible to win. By entering, you agree to be bound by these Official Rules and Regulations. Sponsor reserves the right to cancel and re-schedule the postcard promotion at any time if the technical transmissions become corrupted or interrupted.

**PRIZES**: Ten (10) winners will be awarded one Family Fun Pack, which includes four (4) Wisconsin State Fair admission tickets and a voucher for six (6) Cream Puffs valid for the 2024 Wisconsin State Fair, presented by UScellular, August 1 – 11, 2024 at Wisconsin State Fair Park in West Allis, Wisconsin. Retail Value of promotion is: \$97.00 (Ninety-seven Dollars) per Family Fun Pack. Lost or stolen prizes will not be replaced by Sponsor.

No prize substitution or transfer is permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value for any reason. All taxes and any other incidental expenses on prizes are the sole responsibility of each winner.

**SELECTION OF WINNERS:** Ten (10) winners will be selected by Thursday, May 2, 2024. Winners will be chosen by Administrator, based on uniqueness, creativity, and compliance with the Official Rules. Administrator's decisions and interpretations on all matters relating to the Contest and these Official Rules are final and binding in all respects. Administrator reserve the right to disqualify any participant or winner. Potential winners will be notified via email (or mail in the absence of email) at Sponsor's sole discretion by the email address (or address) included on the postcard. Winner must meet all eligibility requirements. Return of a prize or inability of Administrator to contact a potential winner via email or mail within forty-eight (48) hours of selection may result in disqualification of such potential winner, and an alternate winner may be selected by random drawing at Administrator's discretion. In the event a winner declines a prize, Administrator may, at its discretion, select an alternate winner by random drawing.

**PUBLICITY, PRIVACY & PRIZE NOTIFICATION:** By submitting a postcard, entrant grants the Administrator worldwide, royalty-free permission to use name, character, photograph, and likeness in connection with the postcard promotion of this and other postcard promotions of the like. All submitted entries become the property of Administrator and will not be acknowledged or returned. Only eligible entries received within Entry Period will be included in the prize drawings. Sponsor reserves the right to cancel the Promotion at any time in its sole discretion.
