



RV Park Rules and Regulations

GENERAL INFORMATION:

- These rules are for health, cleanliness, legality and enjoyment of all guests and visitors.
- Please be considerate and courteous to your neighbors and others
- All sites are accessible to persons with disabilities.
- Site occupancy is limited to self-contained units.
- Quiet hours are from 11pm-7am daily
- RV Park management reserves the right to adjust campsites at our discretion.
- Propane grills are permitted. NO OPEN WOOD FIRES OR CHARCOAL GRILLS
- All trailer jacks must have a protective device between the pavement and the bottom of the jack
- Custom fit RV skirting is permitted. Any DIY skirting must be approved by management
- Hose splitters are not permitted
- Occupants must handle and store fuel oil, flammable liquid and petroleum gases in compliance with national and state standards.
- Occupants and their guests are required to comply with all Wisconsin State Fair Park Rules, Regulations, Policies and State Administrative Codes, as well as all state laws. Failure to comply may result in removal from the Park.
- Please exercise good judgement if you decide to leave your children at the Park without supervision. You are responsible for their welfare and are liable for their behavior.

PERMITS/CHECK IN/CHECK OUT:

- All guests must check in at the RV Park office to obtain permits prior to setting up. Permits are site-specific; Guests cannot move to another site without prior approval.
- Check in begins at 2 pm, permits expire on the final day at 12:00 noon.
- Permits must be displayed and visible to Wisconsin State Fair Park personnel.
- Check out time is 12:00 pm. If you plan to stay longer than your original permit allows, the

earlier you re-register, the better chance of keeping your site.

- If your camping unit is in a campsite after your permit has expired and we cannot get in contact with you, the camping unit will be towed at the owner's expense.
- A \$10 fee will be charged for early check-in or late check out.

PROHIBITED:

- Disorderly conduct, disturbing the peace, drunkenness, obscene language, obnoxious, disruptive or vulgar behavior. These will be grounds for immediate eviction without refund.
 - Drug Possession or Use – Illegal drugs are prohibited on State Fair Park property. Person(s) caught in violation of this rule are subject to arrest. If you observe illegal drug use at a site, you are encouraged to notify our Police Department at 414-266-7033. Any information you report will be confidential.
 - Engaging in activities that disrupt other campers between 11:00 pm and 7:00 am.
 - Operating any device that makes excessive noise.
 - Fireworks
 - Discharging of firearms
 - Open wood fires
 - Loud music at any time
 - Entering any building or area closed to the public or restricted by sign
 - Destroying or defacing trees, plants, natural features or structures of Wisconsin State Fair Park.
 - Destroying, defacing or removing property of others in the Park.
 - Soliciting business or distributing property of others in the Park.
 - Washing recreational vehicles and/or cars with hoses.
 - Having "For Sale" signs on any items or vehicles.
 - Drilling or staking anything into the pavement. You must use weights to hold down items.
 - Skateboards, electric skateboards and hover boards

RV Park Rules and Regulations

PETS AND OTHER ANIMALS:

- NO pets allowed in showers or restrooms.
- Only service animals are allowed in RV Park lobby and laundry areas.
- Owners must clean up after their pets.
- If outside, pets must always be on a leash (8 ft. or less).
- Do not leave pets tethered on a leash or chain or in a pen outside overnight or when you are absent, or your site is unattended.
- Pets should be exercised in posted area, located in the southeast corner of the RV Park.
- Pets must be controlled in a manner that does not endanger or disturb other campers.
- Aggressive breed dogs that attempt to attack or bite a guest will not be allowed to stay in the RV Park.
- Horses and other livestock are not permitted in the RV Park. Only exception is Police Mounted Patrols.

PARKING:

- Camping units must be parked within the limits of the assigned site(s). If there is an emergency water shut-off marked in blue on the ground of your site, it MUST be un-covered and accessible at all times.
- Only one vehicle in addition to the camping unit is allowed at each site.
- Camping units must be registered
- Additional vehicles or trailer must be parked in designated parking areas.

VEHICULAR TRAFFIC:

- ALL vehicles shall operate only on roads, parking lots and similar areas designated for their use. The Racetrack is off limits to all vehicle traffic except for the annual State Fair or a specific event.
- ALL golf carts, UTV and ATV must have a Wisconsin State Fair Park Cart Permit. Check with RV Park staff for directions on getting a golf cart, UTV, ATV permit.
- ALL unlicensed vehicles such as trail bikes, minibikes, off road vehicles, snowmobiles and dune buggies are prohibited.
- ALL vehicles operated in the Wisconsin State Fair Park are subject to the State of Wisconsin motor vehicles codes, State Administrative codes and Rules of the State Fair Park Board.
- Please observe a speed limit of 5 mph within the RV Park

REFUSE/TRASH AND LIQUID WASTE:

- Refuse/trash must be placed in designated dumpsters, located at each corner of the park and at the back of the office.
- All liquid waste must be contained in proper holding tanks and deposited in specific sanitary dumping stations.
- NO liquid waste (including gray and black water) may be poured on the ground or grass.
- Dumpsters in the Park are for personal trash only.
- DO NOT leave trash outside your RV.
- Sites are to be kept clean and orderly
- Please leave the laundry area as clean as you would like to find it.
- If a site, laundry, showers or restrooms is in need of attention, please notify the RV Park Staff
