Introduction AGENCY DESCRIPTION

The Wisconsin State Fair Park Board of Directors includes seven members appointed by the Governor, with the advice and consent of the Senate. It also includes four state legislators, the Secretary of the Department of Tourism and the Secretary of the Department of Agriculture, Trade and Consumer Protection. The Board is directed to oversee the Fair Park, set policy and appoint a Chief Executive Officer to manage and supervise the 200 acres for the annual 11day State Fair, Harvest Fair, and multiple regional and local events on a year-round basis.



State Fair Park is a year-round entertainment venue that hosts activities, events, meetings and more. Home to the Exposition Center, Tommy G. Thompson Youth Center, Milwaukee Mile Speedway, Wisconsin Products Pavilion and many other facilities, hundreds of events are held at the Fair Park each year, including the annual Wisconsin State Fair, presented by U.S. Cellular. The Fair welcomes and average of one million guests each year, and other events held at the Fair Park bring in another one million visitors annually.
