

Camping at the Milwaukee Mile Speedway – Rules and Regulations

The following rules, policies and procedures are subject to change. Wisconsin State Fair Park (WSFP) officials reserve the right to refuse admission or eject persons violating any law or policy.

GENERAL INFORMATION & REQUIREMENTS:

- By purchasing a Milwaukee Mile infield camping pass or event ticket, you are agreeing to comply with all Wisconsin State Fair Park and camping rules, terms, regulations, policies, state administrative codes, and all state and federal laws. Failure to comply may result in immediate ejection without refund
- Rules apply to all guests including visitors. The rules are for health, cleanliness, legality, and enjoyment of all guests
- All sites are accessible to persons with disabilities
- A recreational vehicle (RV) is required to occupy a site (camping trailers, motorhomes, camper vans) **Tents are NOT allowed on property**
- Fuel, oil, flammable liquid, and petroleum gases must be handled and stored in compliance with national and state standards
- Spectators are not allowed in the Paddock without proper credentials
- WSFP assumes no responsibility for loss, theft, or damage to personal property. Please respect the right of others
- All campers must depart by 11:00 AM on Monday after the event
- Camping units must be self-contained
- The camping unit, one permitted vehicle, and any other equipment and items must be contained within the 20'x50' site limits

VEHICULAR TRAFFIC & PARKING:

- ALL vehicles shall operate only on roads, parking lots and similar areas designated for their use and for load-in and out purposes only
- Please drive cautiously and observe a speed limit of 5 mph
- Vehicles driven after dark must have working headlights
- Golf carts, ATVs, scooters, and all unlicensed vehicles such as trail bikes, minibikes, off road vehicles, and dune buggies are prohibited
 - If brought to the facility, they will be taken to an impound area and returned to the owner at the end of the weekend
 - A ZERO TOLERANCE policy will be in effect for the use of these vehicles and no warnings will be given
- ALL vehicles operated in the Wisconsin State Fair Park are subject to the State of Wisconsin motor vehicles codes, State Administrative codes, and Rules of the State Fair Park Board and Rules of the Milwaukee Mile Speedway

VEHICULAR TRAFFIC & PARKING (CONTINUED):

- Entrance to the infield is restricted if the track is in use. Please reference posted access times or refer to WSFP/Race personnel for directions and times to enter or exit the infield
 - Access to the infield via the Tunnel Entrance may alternatively be used. Please note that the Tunnel has a clearance of 8' 8" high by 9' 0" wide
- Vehicles are subject to search by WSFP Public Safety or Police upon entering the facility
- All vehicles must be street-licensed for the state of Wisconsin, have a valid license plate, and the driver must possess a valid driver license to operate the vehicle on the property

REGISTRATION/CHECK-IN:

- Permitted registration times vary, are to be determined, and subject to change at any time
 - Registration dates and times will be provided prior to the event via email and posted on the event page. It is the camper's responsibility to plan accordingly for arrival during these times
 - Registration will begin on the Friday before the event. Load in or dropping off the camping unit prior to the Friday before the event will not be permitted
- Upon arrival of a camping unit, the Milwaukee Mile infield camping pass must be presented, and <u>each occupant</u> must present their <u>weekend</u> event ticket to start the registration process
 - Only persons with weekend event tickets will be permitted in the camping area
- Each weekend event ticket presented with a Milwaukee Mile infield camping pass will in return receive an infield camping wristband
 - Camping parties arriving separately will be responsible for having their weekend event ticket on their person upon arrival and for receiving their infield camping wristband from the person who registered/arrived with the camping unit
 - All occupants of the campsite must wear their infield camping wristband for the duration of the event as an indication of a permitted infield camping occupant with 24-hour access to the infield and select WSFP facilities
- Campsites are assigned on a first come, first served basis
- Ten (10) occupants are permitted at each campsite, and at least one occupant must be an adult of 18 years of age or older

Violation of any state law, administrative code, or any rules by a guest or visitor of a guest having a campsite is cause for ejection from the park per State Administrative Code SFP 2.10(2). Wisconsin State Fair Park personnel reserves the right to revoke camping rights without refund, refuse service to any person, and make changes to the rules, policies, and fees when necessary



<u>Camping at the Milwaukee Mile Speedway – Rules and Regulations</u>

SITE AMENITIES & POLICIES:

- Site size and features may vary. <u>Generally</u>, sites are:
 - o 20' x 50'
 - Dry camping (no utilities such as water, electric, or sewer)
 - Large enough for the camping unit and one vehicle
 - Vehicles that do not fit within the campsite space will need to purchase a parking pass and park in designated parking areas
- Use of a generator at the campsite is permitted from 7am 10pm if it is not disturbing other campers
 - WSFP reserves the right to require campers to turn generators off if they are disrupting other campers
- There is one permanent restroom facility in addition to portable toilets located throughout the infield
- Other amenities are available to infield camping guests at the nearby <u>WSFP RV Park</u>, located in the Northeast corner of WSFP
 - Men's and Women's Showers
 - o <u>Coin Laundry</u>
 - o <u>Restrooms</u>
 - o Water Fill Station
 - Propane Filling Station
 - o Sanitary / Dump Station
- Guests cannot move from their assigned campsite to another campsite without prior approval per State Administrative Code SFP 2.10(5)

QUIET HOURS & POLICIES:

- Quiet hours are from 10pm 7am daily in all camping areas
 Generator use is NOT permitted during quiet hours
- Playing music out loud (radio, speaker, etc.) is not permitted after 10pm
- Extensive or professional sound systems are prohibited at all times
- Loud music is prohibited. WSFP reserves the right to require camper to turn music down or off

REFUSE/TRASH & LIQUID WASTE:

- Refuse/trash must be placed in designated barrel and dumpsters
- Coals/ash from grills must be properly disposed. There are coal/ash deposit barrels located throughout the infield
- All liquid waste must be contained in proper holding tanks and deposited in specific sanitary dumping stations
 - o The dump station is located at the nearby WSFP RV Park
- NO liquid waste (including gray and black water) may be poured or leaking on the ground.
- Sites are to be kept clean and orderly and should be clean and free of garbage upon departure

PROHIBITED:

- East Entrance to the infield if the track is in use
- Use of a generator after 10pm, and use of a generator if it is disturbing other patrons
- Tampering with any electrical outlets on WSFP property
- Pets/animals (service animals providing assistance to an individual with a disability are welcome)
- Disorderly conduct, disturbing the peace, drunkenness, obscene language, obnoxious, disruptive, or vulgar behavior
- Illegal acts including, but not limited to theft, vandalism and public indecency
- Illegal substances of any kind (illegal drugs and substances or drug paraphernalia)
- Offensive or obscene materials (flags, signs, clothing, etc.)
- Engaging in activities that disrupt other campers
- Fireworks (including firecrackers or bottle rockets)
- Campfires/open fires (enclosed grills are permitted)
- Discharging of firearms
- Roller blades, bicycles, skateboards, skates, hover boards, pogo sticks, and scooters
- Frisbees, balloons, beach balls or any other projectiles
- Camping tents and similar structures used for camping
 - Canopies are not permitted for the use of camping
 - Canopies must be fire rated, weighted down and not prevent sightline obstructions
- Entering any building or area closed to the public or restricted by sign
- Destroying, defacing, cutting, driving nails into or attaching lines or any other objects to WSFP structures or nature features (including, but not limited to: trees, bushes, fencing, light poles, signposts, or buildings)
- Drilling or staking anything into the pavement weights must be used to hold down items
- Soliciting of any kind
- Bringing prohibited items onto the property
 - Prohibited items listed below

SAFETY & SECURITY:

- There is 24-hour Public Safety and Police patrol to ensure the safety of all campers
 - Public Safety and Police are in direct contact with onsite medical personnel

Camping at the Milwaukee Mile Speedway – Prohibited Items and Terms

The following items are prohibited through the Milwaukee Mile Speedway gates:

- Illegal drugs or substances and paraphernalia
- Firearms, knives, and all other weapons or objects that could be used as weapons
- Fireworks, flares, sparklers, or explosives
- Nosie makers and air horns
- Large bags over 9" x 10" x 12"
- Hard-sided coolers
- Camelback style hydration packs
- Large stick umbrellas or golf umbrellas (collapsible/telescopic umbrellas are permitted)
- Outside food and beverages (unless needed for infants or dietary needs)
- Glass or ceramic containers
- Aerosol cans (with the exception of spray sunscreens and bug sprays)
- Alcohol of any kind
- UAV drones
- Pets (except service animals)
- Selfie sticks, tripods, and monopods of any kind
- Banners or flags on poles
- Offensive or obscene materials (flags, signs, clothing, etc.)
- Laser pointers
- Skateboards, hoverboards, roller skates, inline skates, bicycles, tricycles, or unicycles
- Foot powered or electric scooters (such as a Bird, Lime, or Lyft scooter)
- Bicycles, tricycles, or unicycles
- Frisbees, balloons, beach balls or any other projectiles
- Stadium seats
- Other carry-ins as determined by WSFP management

TERMS

I UNDERSTAND THAT PARTICIPATION IN THIS EVENT IS AT MY OWN RISK AND COMES WITH RESPONSIBLITIES.

By use of this ticket and/or other event admission material, I am agreeing to each and all of the following terms:

- I expressly assume all risk incident to the event, whether occurring prior to, during or subsequent to the actual conduct of the event. I HEREBY RELEASE all event participants, sanctioning bodies, the State of Wisconsin, INDYCAR, LLC ("INDYCAR"), and their officers, directors, members, owners, successors, assigns, agents, employees, representatives, and affiliates from any and all claims arising from the event, including claims of negligence of released parties.
